Terms & Conditions:

- 1. The distributors are instructed to submit their tenders of the above said items along with company authorization letter in the form of an affidavit on 100/- bond paper.
- 2. In case of manufacturers they should submit their tender mentioning their authorized distributor in the form of affidavit on ₹100/- bond paper.
- 3. The tenders without authorization will be rejected summarily.
- 4. Qualified suppliers/Manufacturers have to deposit EMD of ₹.25,000/-(Rupees Twenty Five Thousand Only) at NIMS Main IP cash Counter at old Building/ EMD's in the form of DD in favour of The Director NIMS. The EMD amount shall be returned to the successful bidders after completion of tender period without interest.
- 5. Period of tender is initially for one year or till finalization of RC whichever is later.
- 6. In case of breach of any tender conditions the contract will be terminated and deposits will be forfeited to NIMS.
