The Tenure period is for (1) one year. During the period of Tenure an amount of Rs.17,000/- p.m. will be paid as stipend. The Candidate has to attend Written Test /interview at NIMS. - A. Selection will be made as per Merit based on the marks obtained in Qualifying Examination.
- B. The eligible qualification should be recognized by the Nursing Council of India.
- C. On Completion of One Year Tenure the Candidates will be relieved.
- D. SC/ST Candidates has to pay Rs.500/-
- E. The One Year Tenure does not confer any right for employment. The Staff Nurse (Tenure) shall follow the instructions of the Matron / Nursing Superintendent or any other Officer nominated by Medical Superintendent & Director.
- F. During the Tenure period the candidates are eligible for 15 days of casual leave only.
